Janet gave report on fall mini-meet. Had a good turnout.

John Draftz gave report on Railfair. Turnout OK but low. Location was OK but the station area is best. No permanent location was identified as of yet.

Glenn Saber encouraged good club prospectus to help attract offers.

Status of Doyle raised. No one had a recent update.

Layout plaque updated with Bob Dennison's name.

Beat the Heat bus tour was discussed.

Concern for cost and thus interest. Facilitating carpools may be the best option.

John Draftz presented plastic holders containing pictures of layout operating accessories. Need to find practical way to attach – maybe under a button.

Newsletter articles encouraged. Peter can edit. Photos also help.

Nick Schnakenberg offered use of his garage for mobile layout. Sloped drive poses a problem requiring two or more people to maneuver trailer. Staying at Adobe is best option for now. John Zaval and John Draftz will check on the availability and cost of a large (10x20?) storage unit where both the mobile

layout and things in our present storage unit could be stored.

John Draftz gave a Winter Cactus update. Have about 20% tables sold. Cactus swap meet raffle prizes were discussed. Train rides are limited interest. Keep prizes train related versus sports, etc. Have 8-10 prizes.

Frequency of the race track was discussed but no decision was reached.

Snaps on the cover of the mobile layout are not what was ordered and create a problem using them. Two options were retrofit cover with correct snaps or get new cover with correct snaps. John Draftz and John Zaval will research.

Need to ensure we have volunteers at the various venues.

Moving the Summer Cactus was discussed. In November, the third Saturday at one point was the Cal Stewart swap meet in LA area and we avoided that weekend. Cal Stewart has not been held for some time thus that weekend is now available. The conclusion/recommendation is to move the fall mini-meet to the third Saturday in November. Move the Summer Cactus to the fourth Saturday in September as a Fall Cactus. Make July Fourth Saturday a regular meeting. This possible change effective 2023 has been presented to both North Phoenix Baptist and Our Savior churches. Both have made changes accordingly but have left their calendars with the present schedule just in case.

It was also noted that the Baptist Church SE parking area didn't seem to be used by many




